[Methodology: Spelling, punctuation and/or grammar have been corrected in some instances for ease of reading and to facilitate searches of the database. Where the meaning is not compromised by adhering to the spelling, punctuation or grammar, no change has been made. Corrections or additional notes have been inserted within brackets or footnotes. Blanks appearing in the transcripts reflect blanks in the original. A bracketed question mark indicates that the word or words preceding it represent(s) a guess by me. The word 'illegible' or 'indcipherable' appearing in brackets indicates that at the time I made the transcription, I was unable to decipher the word or phrase in question. Only materials pertinent to the military service of the veteran and to contemporary events have been transcribed. Affidavits that provide additional information on these events are included and genealogical information is abstracted, while standard, 'boilerplate' affidavits and attestations related solely to the application, and later nineteenth and twentieth century research requests for information have been omitted. I use speech recognition software to make all my transcriptions. Such software misinterprets my southern accent with unfortunate regularity and my poor proofreading skills fail to catch all misinterpretations. Also, dates or numbers which the software treats as numerals rather than words are not corrected: for example, the software transcribes "the eighth of June one thousand eighty six" as "the 8<sup>th</sup> of June 1786." Please call material errors or omissions to my attention.]

Robert Russell Senior<sup>1</sup> who is a Revolutionary pensioner & a man of truth & veracity came before me & made oath that he was well acquainted with Ralph Hinman & Baily Hinman of this County both of whom were his neighbors – that they both enlisted in Captain Snead's [Thomas Snead's] Company with the witness for the term of three years – & said Ralph Hinman was killed at Germantown [October 4, 1777] & said Baily Hinman served out his tour – that he was captured at Germantown & in prison to with the witness & was in [word too faint to discern ] in service & imprisonment nearly or quite four years.

Given under my hand & seal as a Justice of the peace in the said County the 21<sup>st</sup> day of January 1834

This is to Certify, That it appears from a List in this Office of such Officers and Soldiers of the Virginia Continental Line, during the Revolutionary War, as settled their Accounts, and received Certificates for the balance of their Full Pay, according to an Act of Assembly, passed the November Session 1781, that a Certificate issued on the 6<sup>th</sup> day of November 1784, in the name of Bailey Hinman, as a Soldier of Infantry for £16.1.? [last digit unclear], which Certificate appears to have been delivered to Colonel Cropper and was given for services prior to the 1<sup>st</sup> January 1782.

This is to Certify, That it appears from a List in this Office of such Officers and Soldiers of the Virginia Continental Line, during the Revolutionary War, as settled their Accounts, and received Certificates for the balance of their Full Pay, according to an Act of Assembly, passed the November Session 1781, that a Certificate issued on the 30<sup>th</sup> day of April 1785, in the name of Ralph Hinman, as a Soldier of Infantry for £13.17.4, which Certificate appears to have been delivered to Colonel Cropper and was given for services prior to the 1<sup>st</sup> January 1782.
