I certify that Levin Hyslop [W7858] who is a Revolutionary pensioner & a man of truth & veracity came before me & made oath that he served in the Va. Cont'l. line from the beginning to the end of the Revolutionary War & has recd 200 acres of land for his services – that he was intimately acquainted with Southey & Timothy Colony of the same County who enlisted in Capt Sneads [Thomas Snead] Co for the term of during hte war, & served till the war ended. Given under my hand & seal as a Justice of the peace for the County of Accomack this 20<sup>th</sup>[?] Jany 1834. Wm. R. Custis JP

Robert Russell Sen'r [W5753] who is a man of truth & veracity & a Revolutionary pensioner came before me & made oath that he served in Capt Tho. Snead's Company in the Va Cont'l line in the Revolutionary War, & that Southey Colony & Timothy Colony both enlisted in said Company for the term of during the War & served till the war ended. Given under my hand & seal as a Justice of the peace in & for the County of Accomack this 21<sup>st</sup> day of January 1834 Wm. R. Custis JP

This is to Certify, That it appears from a List in this Office of such Officers and Soldiers of the Virginia Continental Line, during the Revolutionary War, as settled their Accounts, and received Certificates for the balance of their Full Pay, according to an Act of Assembly, passed the November Session, 1781, that a Certificate issued on the 30<sup>th</sup> day of April 1785, in the name of Southy Colony as a Soldier of Infantry for £15.17.4, which Certificate appears to have been delivered to Colo. Cropper and was given for services prior to the 1st January, 1782.

Given under my hand at the Auditor's Office, Richmond, this 5th day of February 1834.

The affidavit of Levin Hyslop a Revolutionary Soldier Aged Seventy Eight being first duly sworn deposeth and sayeth that he knew Southy Colony Southy Prewit John Prewit Holliday White Ephraim Watson Shadrich Fitzgerald Elisha Garrot & Thomas Garrot during the revolutionary war – that the forgoing men enlisted in the 9<sup>th</sup> Virginia Redgmt and went to the north and was in service absent from this County upwards of three years as this deponent distinctly recolects
