[Methodology: Spelling, punctuation and/or grammar have been corrected in some instances for ease of reading and to facilitate searches of the database. Where the meaning is not compromised by adhering to the spelling, punctuation or grammar, no change has been made. Corrections or additional notes have been inserted within brackets or footnotes. Blanks appearing in the transcripts reflect blanks in the original. A bracketed question mark indicates that the word or words preceding it represent(s) a guess by me. The word 'illegible' or 'indecipherable' appearing in brackets indicates that at the time I made the transcription, I was unable to decipher the word or phrase in question. Only materials pertinent to the military service of the veteran and to contemporary events have been transcribed. Affidavits that provide additional information on these events are included and genealogical information is abstracted, while standard, 'boilerplate' affidavits and attestations related solely to the application, and later nineteenth and twentieth century research requests for information have been omitted. I use speech recognition software to make all my transcriptions. Such software misinterprets my southern accent with unfortunate regularity and my poor proofreading skills fail to catch all misinterpretations. Also, dates or numbers which the software treats as numerals rather than words are not corrected: for example, the software transcribes "the eighth of June one thousand eighty six" as "the 8<sup>th</sup> of June 1786." Please call material errors or omissions to my attention.]

### Declaration

In order to obtain the benefit of the acts of the Congress of the United States of America passed for the benefit of the surviving Soldiers, or their widows or their heirs legal after the decease of Soldiers who may have served in one or more campaigns in behalf of the United States which acts are of force for the above description of Persons.

On this 13th day of February 1854 personally appeared before me the undersigned a Justice of the Peace within and for the County of Fayette and State of Georgia John Fuller a resident of Jonesborough, in the County of Fayette and State of Georgia, aged ninety-eight years, who being first duly sworn according to law, doth on his oath make the following declaration, in order to obtain the benefit of the provision made by the acts of Congress which are now of force for the benefit of the heirs legal of deceased Soldiers who served one or more Campaigns in behalf of the United States of America in any of the wars which may have been declared against the United States as aforesaid. And now deponent saith that he was born and raised in Kershaw district South Carolina, that he is the only surviving heir of his Father, John Fuller Senior deceased who did as well as deponent can at this time recollect go into Braddock's War from the above named place, on or about the Commencement of the same and served in the same until the time of Braddock's defeat,<sup>1</sup> at which time and place deponent's father John Fuller Senior was honorably discharged and returned to Kershaw District South Carolina after which he the said John Fuller Senior removed to Columbia County, Georgia and resided in the last named County and district between forty and forty-five years, since that the advanced age of one hundred and Six years and deponent further states that he recollects distinctly of hearing his Father frequently in his lifetime say he that he was at the Braddock's defeat, and that he fought in the American line and saw General Braddock when he was dying and heard him [say] his last words to General Washington whilst in the act of dying, deponent recollects his Father having gone into said service and also recollects his returning to Kershaw district South Carolina after his discharge from said Campaign and said discharge is lost or mislaid since the death of his Father so that he cannot control the same at this time and that deponent does hereby relinquish all claims in said case but the present one and that his name has never been enrolled for the same in any State or Territory in the Union.

Claim of John Fuller, a Resident of Fayette County Georgia for an amount of Pension or increase of Pension or Bounty Land Warrants, which may be due you the said John Fuller, as the Lawful heir of his Father, John Fuller Senior for services rendered by the said John Fuller Senior in the American revolution against Great Britain as provided for by the acts of Congress of the United States of America which are now both force for the benefit of the heirs legal of deceased Revolutionary Soldiers.

State of Georgia County of Fayette

Be it known that on this tenth day of February 1854 before the undersigned a Justice of the Peace in and for the County aforesaid personally appeared John Fuller a resident of said County and State aforesaid and made oath according to law, that he is the identical person who executed the foregoing Power of attorney for the purpose herein expressed that he is the only surviving heir legal of his Father John Fuller Senior who was a soldier in the revolutionary, against Great Britain and who entered into said service as a Volunteer from Kershaw district South Carolina about the Commencement of the Revolutionary War, and served during the War, say about the term of seven years. The Captain's name under which deponent's Father served he does not at this time recollect. But as well as deponent can at this time recollect the Major's name was Hardin and the Colonel's name was Henry Candler, all of whom were at that time under the Command of General George Washington and the said John Fuller Senior was honorably discharged at the City of Little York in the State of Virginia after which he Removed to the State of Georgia and died in Columbia County in said State between forty and forty-five years ago at the age of One hundred and Six years, deponent's age at this time being ninety-eight years, deponent further states that he has never Received any Benefit for the above stated Service in any manner whatever and that he has never heretofore sent up any Claim whatever for the same in his own individual Capacity or in any other manner whatever. But that for the granting of the above claim deponent will ever pray &c. He hereby relinquishes every claim in the above case but the present and he declares that his name is not on the Pension Roll for the same. Sworn to before me this 10th day of February 1854.
