[Methodology: Spelling, punctuation and/or grammar have been corrected in some instances for ease of reading and to facilitate searches of the database. Where the meaning is not compromised by adhering to the spelling, punctuation or grammar, no change has been made. Corrections or additional notes have been inserted within brackets or footnotes. Blanks appearing in the transcripts reflect blanks in the original. A bracketed question mark indicates that the word or words preceding it represent(s) a guess by me. The word 'illegible' or 'indecipherable' appearing in brackets indicates that at the time I made the transcription, I was unable to decipher the word or phrase in question. Only materials pertinent to the military service of the veteran and to contemporary events have been transcribed. Affidavits that provide additional information on these events are included and genealogical information is abstracted, while standard, 'boilerplate' affidavits and attestations related solely to the application, and later nineteenth and twentieth century research requests for information have been omitted. I use speech recognition software to make all my transcriptions. Such software misinterprets my southern accent with unfortunate regularity and my poor proofreading skills fail to catch all misinterpretations. Also, dates or numbers which the software treats as numerals rather than words are not corrected: for example, the software transcribes "the eighth of June one thousand eighty six" as "the 8th of June 1786." Please call material errors or omissions to my attention.]

State of Kentucky Sct.

On this 16th day of September 1823 Personally appeared in open Court being a Court of Record; expressly so Constituted and Established by the laws of the State creating and Establishing the same –

James M Hulet, residing in Lewis County aged 59 years who being first duly sworn according to law doth on his oath make the following Declaration in order to obtain the provisions made by the Acts of Congress of the 18th of March 1818 and the first of May 1820. That he the said James M Hulet Enlisted for during the War in August 1778 and continued in the Army until September 1783. He was Enlisted in the State of Virginia in the company commanded by Uriah Springer in the Regiment commanded by Colonel John Gibson who commanded the 7th Regiment of the Virginia line on the Continental Establishment; and was discharged from the said Service at Pittsburgh in September 1783.

He annexes as part of his declaration the [word written over and indecipherable] of said Uriah Springer taken before a Justice of the Peace in the State of Pennsylvania, duly Authenticated for the purpose of proving the Service rendered.

And in pursuance of the act of the first of May 1820, I do solemnly swear that I was a resident Citizen of the United States on the 18th day of March 1818 and that I have not since that time by gift, sale or in any manner whatever disposed of my property or any part thereof with intent thereby so to diminish it as to bring myself within the provision of an act of Congress entitled “an act to provide for certain persons engaged in the land and naval service of the United States in the revolutionary war” passed on the 18th day of March 1818, and that I have not nor has any person in trust for me any property, or securities, contracts or debts due to me nor have I any income other than what is contained in the schedule hereto annexed and by me subscribed Viz. one small cow and Calf worth about \$9 – two head of Sheep worth about \$3, one Loom worth \$3 – one Spinning Will worth \$1.45, one Kettle worth \$2, two Broken Pots worth one dollar – Seven head of hogs worth \$8, two chairs and two Barrels worth one dollar, one account for 15 Bushels of Corn (Bad), one other account for one Barrel of Tar (Bad), the Debts he owes is about \$3. The schedule amounting in the whole to the sum of \$28.50.

The said James M Hulet further States on oath that his Occupation is a Blacksmith, to Trade, but being afflicted with the Tisic [sic?] he is only able to work at times – His family consist of a wife about 30 years of age – and five small Children, not of whom are able to do much labor – And moreover states that he is in such Indigent Circumstances as to be unable to Support himself

without the assistance of his country.



I Uriah Springer late a Captain in the 13th Virginia Regiment of the Army of the Revolution said Regiment by different arrangements became entitled the 7th Regiment at the end of the war. Now I do Certify that James Hulet was a Soldier in my Company in said Regiment he having enlisted in August 1778 and continued in my Company and in said Regiment until September 1783 when he was regularly and honorably discharged
