[Methodology: Spelling, punctuation and/or grammar have been corrected in some instances for ease of reading and to facilitate searches of the database. Where the meaning is not compromised by adhering to the spelling, punctuation or grammar, no change has been made. Corrections or additional notes have been inserted within brackets or footnotes. Blanks appearing in the transcripts reflect blanks in the original. A bracketed question mark indicates that the word or words preceding it represent(s) a guess by me. The word 'illegible' or 'indecipherable' appearing in brackets indicates that at the time I made the transcription, I was unable to decipher the word or phrase in question. Only materials pertinent to the military service of the veteran and to contemporary events have been transcribed. Affidavits that provide additional information on these events are included and genealogical information is abstracted, while standard, 'boilerplate' affidavits and attestations related solely to the application, and later nineteenth and twentieth century research requests for information have been omitted. I use speech recognition software to make all my transcriptions. Such software misinterprets my southern accent with unfortunate regularity and my poor proofreading skills fail to catch all misinterpretations. Also, dates or numbers which the software treats as numerals rather than words are not corrected: for example, the software transcribes "the eighth of June one thousand eighty six" as "the 8th of June 1786." Please call material errors or omissions to my attention.]

[p 2: Printed form of Indent No. to 43 Book N dated March 1, 1785 "delivered to Mr. Mathias Brown this our Indented Certificate for the Sum of Eleven pounds Four Shillings Sterling for Cattle driving in 1780 as per account Audited...."]

[p 3: reverse of the above Indent bearing endorsements signed by what appears to me to be "Malfus Braun" which I think may well be the veteran's German name which the auditor's office changed to "Mathias Brown." If anyone knows for sure, please let me know.]

Also a signature which appears to me to be "Mary broun"

[Note: page 8 of the file indexed under the name Matthew Brown AA819 was misfiled. That document relates to "Mathias Brown" and reads as best I can decipher, as follows:

Sir

As the particular [word too faint to discern] & situation of the Bearer Mathias Brown requires a degree of indulgence, his Excellency the Governor desires you will take up his account & audit it that he may receive his Indent. I am Sir
